Sounddogs.com presents its own desktop application, to bring 320,000 high-quality sounds directly to you.

The software features a Cloud Library including Online, Advanced and Fast Search, Navigation through categories and even Personal Organization building your own Sound Effects Database with Local Libraries.

A Built-in preview Player lets users listen, select sounds and direct download them in High Resolution format with full metadata.

The subscription based license system avoids dealing with browsers, payments and download links. Easily drag and drop the downloaded audios from the application directly to any DAW or Audio Editor software as Pro Tools.

### System Requirements

Apple OSX 10.7.3 or higher, running Java 8 or higher

Windows 10, 8, 7, Vista, and Server (64 bits OS)

### How to Install

1. Download the installer "SoundDogs-1.1.2.dmg"

#### Win

2. Double click the "SoundDogs-1.1.2.exe" and follow the Setup Wizard

#### Mac

2. Double click the "SoundDogs-1.1.2.dmg" to mount it.

3. Drag "SoundDogs" icon into your Applications folder.

4. Open "SoundDogs" from your Applications folder.

5. You will be prompted with the below window, press **Open**.

6. If this fails, you may need to select "Security & Privacy" from the "System Preferences" window. Select the "General" tab, and select the lock in the lower left corner to **allow** changes. Enter your computer username and password, then select "Unlock." In the "**Allow apps downloaded from:**" section, select the radio button to the left of "Anywhere" or the button "Open Anyway" if applicable

**Mac & Win.** Start Sounddogs and enter your License Key to activate the software, it will look something like this XX99-XXXX-XXX9-XXX9-9XX9-9XX9-99XX





*Pin current Audio* using the shortcut ⌘P (Mac) or CtrlP (Win) to attach it to the player, so you can keep it open when select another one from the results



### To Download a sound:

Select it and Click the Download Button.



You can also do the same thing:

- Using the shortcut ⌘D (Mac) or Ctrl D (Win)
- Clicking on the menu command: "File-->Download"
- Through the right click menu on the file, clicking on **Download**.

All files will be saved in the default current Download/Export Folder which can be chosen from the Preferences.

If you need to change the Download/Export folder, press ⌘+Shift+D (Mac) or Ctrl+Shift+D (Win) instead, and you will be able to choose a new Download/Export folder. From that point, every download and export will be saved on this last chosen folder unless you change it again.


Also, you will be able to drag and drop any file from the preview player directly to any audio software as Pro Tools.

You can *Download a selection* as well. This is useful when you don't need the whole sound but just a specific part of it. In order to select the cut, just drag the mouse over the waveform from left to right to highlight the desired area, then press ⌘D (Mac) or Ctrl D (Win) to export the selection. Or also Drag and Drop the selection directly from the app to a Pro Tools session or the finder.



Please note that when you are working on a file that is already downloaded, the command will automatically change to *Export*, so you can copy that file to a different location or project. Same thing will happen with *Download Selection* and *Bulk Download*, that will switch to *Export Selection* and *Bulk Export*.

On the **Local Tab** you will be able to create your local libraries and organise all your sounds (either files downloaded from Sounddogs or your own local files)

Create a library clicking on the + button. Grab files from your finder and Drop them over the library name:

### FAQs

*-What are the differences between the licenses?*

**Free version:** it will work as a search engine and management tool for your local sound effects libraries. You will still be able to explore and preview our cloud libraries but with a low resolution audio quality

Subscription version: Online access to download more than 324,000 high-quality and full metadata sound files. The previews have a better quality than the free version previews. You will also be able to use the Local mode. Subscription can be used in with three different type of licenses:

REGULAR license: \$200 per user - 2,000 downloads/year (monthly average download: 167 SFXs)

PRO license: \$500 per user - 5,000 downloads/year (monthly average download: 417 SFXs)

PREMIERE license: \$1000 per user - 10,000 downloads/year (monthly average download: 834 SFXs)

*- Is the preview the maximum quality sound?*

No, Previews are a very low quality version of the original sound. Please note that when the app is used in Subscription mode, the previews have a better quality than Free mode previews. All downloaded files will be high quality audio.

*-Can several people be signed in as the same user?*

A Subscriber user can only be signed in to one computer at the time.

*- Are mp3 files accepted for local libraries?*

No, The application only accepts WAV files

*-What are the differences between Cloud and Local library?*

Cloud library: includes all Sounddogs libraries.

Local libraries: are created with local files stored on your computer or external devices

*-Do the downloaded files have full metadata?*

Yes, all the downloaded files will keep full metadata
